Criminal Searches:

•Search Methodology - County and State Criminal records are pulled from the jurisdiction and/or court where they reside electronically, by direct search either in person or using a court established media.

•Search Type - County search types will include felony and misdemeanor records.

•Scope of Record Search - All searches performed are for the past 7 years unless otherwise noted in your pricing exhibit and/or package/product description within the TEAM Background product and system.

Verification Products:

•Search Methodology and Type - Education and Employment Verifications are completed either via phone or electronically.

•Scope of Record Search - Employment verifications by default verify the past 7 years of employment history. DOT Employment Verifications verify the past 3 years of employment for FMCSA and 2 years for PHMSA. For Drug/Alcohol and Accident history, 3 years of information for FMCSA will be obtained and 2 years for PHMSA will be obtained. +Attempts - Attempts for verification services (DOT Employment, Employment, Education, and Professional/Personal References) are defined as an effort to make contact (phone or

electronically) with the source of information. TEAM makes 3 attempts over 5 business days using concentrated processes to verify information in a timely manner. •Employment Verification: When fulfilling an employment verification, our researchers verify the authorized recipient's name, position, applicant's employment start date, end date, previous

position, the reason for leaving, whether the applicant is eligible for rehire and solicit any additional comments. When the request is a DOT employment verification, we ask the previous questions and verify the last position was DOT-related, asking for previous D&A violations and their MVR history.

•Education Verification: When fulfilling an education verification, our researchers verify the authorized recipient's name, position, the applicant's major, minor, degree, type of degree, dates attended, graduation status, and graduation date.
